Course maps will be posted for photographing only. Copies will not be available, nor will they be emailed.

<u>Entering For Exhibition Only (FEO):</u> FEO will be offered at these trials. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is only allowed in the Time 2 Beat and FAST classes Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out to the scribe and the judge.

<u>Fix and Go On (FNG)</u>: FNG is not pre-entered; rather, it occurs during the course of the run. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

<u>Twist N Turn (TnT) (non-regular):</u> See the **Special Attraction** page in this premium for more information.

<u>DOGS ELIGIBLE TO ENTER:</u> This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number. Approved Foundation Stock Service (FSS) breeds are eligible to participate. Bitches in season, aggressive, blind dogs or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance are ineligible to participate.

ENTERING A MIXTURE OF REGULAR AND PREFERRED CLASSES WITHIN THE SAME TRIAL WEEKEND – MULTIPLE JUMP HEIGHTS WITHIN THE SAME TRIAL DAY: A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

MAIL ENTRIES: \$18.00 first entry (incl \$3.50 AKC event service fee) and \$18.00 each add'l entry, same dog/same day (incl \$3.00 AKC recording fee) for regular classes; \$15.00 per entry for non-regular classes (Twist N Turn). Mail entry forms to Trial Secretary listed above and make checks payable to GFDTC. Express mail entries must include the signature waiver allowing them to be left at the secretary's address. Conditional, unsigned, incomplete, illegible, telephone or telegraph entries cannot be accepted and will be returned to the exhibitor. Entries not on official AKC forms, or photocopies of AKC forms without the agreement attached, cannot be accepted. Checks for entry fees will be deposited soon after the closing date. Returned checks do not constitute a valid entry, and a processing fee will be added to all returned checks.

<u>ONLINE ENTRIES:</u> Go to the AKC Agility Online Entry Services home page at <u>www.akc.org/AgilityEntry</u> and follow the instructions there. During the first 48 hours after opening, the initial limit of entries per day designated as either online or paper will be as follows: 150 runs/trial via online entries, 200 runs/trial via paper entries. If either form of entry has not filled at the end of the 48-hour time period, the club reserves the right to decrease or increase either one accordingly.

Entries for Twist N Turn may not be made online, must be made using the entry form attached to this premium, and mailed to the trial secretary before closing.

It is the exhibitor's responsibility to enter their dog in the correct class. The Trial Secretary cannot make any changes (except for move-ups as detailed on Page 3) after the trial closing. Check your entry form carefully and double-check your preliminary confirmation. If you have questions about which class to enter, contact the Trial Secretary before the closing date.

<u>CONFIRMATION OF ENTRY:</u> If an email address is provided, a preliminary confirmation will be sent soon after the entry is received and processed. Please REVIEW IT CAREFULLY and notify the Trial Secretary of any necessary changes as soon as possible. If an email address is not provided, confirmation of entry will be sent by USPS after closing (no preliminary confirmations will be sent). A final confirmation and schedule of judging will be sent after the closing date. If you have not received a confirmation and schedule at least five days prior to the show, contact the Trial Secretary.

<u>MOVE-UPS:</u> Move-ups after entries close must be submitted to the Trial Secretary in writing or email (no phone) before 6:00 PM on Monday, May 15, 2023. Include dog's call name, registration number, owner's name, class you are moving from, and class you are moving to (replying to your final CONFIRMATION EMAIL is an ideal way to complete a move-up). If you do not receive acknowledgement within 24 hours of sending, please contact the Trial Secretary. Day-to-day move-ups will be accepted at the trial. Move-ups for Saturday and Sunday must be submitted in writing no later than 30 minutes after the conclusion of the last class on Friday and/or Saturday. For allowed changes from Novice A to Novice B, refer to Chapter 1, Section 21 of the Regulations for Agility Trials.

REFUNDS: No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

100% of entry fees will be refunded for any reason if a written (or email) request is received by the Trial Secretary on or before the trial closing. After closing, 100% of entry fees (not including online convenience fees) will be refunded for bitches in season if written (or email) notification is received by the Trial Secretary prior to the start of the trial. Verification from a veterinarian may be required at the club's discretion.

<u>OBSTACLES:</u> Obstacles will meet the specifications for obstacles in the edition of *AKC Regulations for Agility Trials* (available at www.akc.org) in effect at the time of the trial.

CATALOG: No hard-copy catalogs will be available. Indicate on the entry form if you would like an electronic version at no cost.

AWARDS: All awards are courtesy of GFDTC. A qualifying score is required for all awards. All awards must be claimed at the show. Ribbons will be awarded for all qualifying scores and for first through fourth place in each height division in each class for all regular and non-regular classes. Title rosettes will be available for regular classes. Special pins will be awarded to any dog earning a double Q (Std/JWW) or triple Q (Std/JWW/FAST) from the Master classes.

<u>SPECIAL AWARDS:</u> GFDTC is offering a variety of special awards that are open to ALL exhibitors. **Unless noted otherwise, all awards require a qualifying score**. Please see following page in this premium for full details

Special Attraction GFDTC Presents TNT - Twist N Turn Class

A non-regular class, that will consist of Tunnels (10', 15' and 20') and 2-4 jumps with bars set on the ground

- Perfect for beginner dogs who might not be ready for a full jumpers or standard course
- Perfect for retired or nearing retired dogs, nothing to jump or climb
- Perfect for dogs that want to have a great time enjoying a few tunnels
- Perfect for everyone wanting to have a fun run with their dog!

This class is open to all dog eligible to enter AKC agility as stated in chapter 1 section 3 of the AKC Agility trial Regulations. Entries will be accepted in our premium, cost will be \$15.

Skill level is Open (for number of obstacles) equipment will be all tunnels, 10 foot, 15 foot & 20 foot, with 2-4 jumps (wings optional) jump bars are set on the ground.

There will be, one class, broken by jump height, preferred & regular. 1st place - 4th place, by Preferred/Regular, jump height. High Scoring by AKC breed group, including All American dogs. Scoring no refusals/run outs, Off courses 5 point fault. Course time deductions 2 point deduction over course time, rounding to whole numbers, time is called at course time plus 20 seconds, then dog is excused. Mandatory Elimination and Mandatory Excusals as in Chapter 5 Sections 5 & 6

Perfect. score 100, Minimum allowable score required to qualify = 85. Must qualify to place

STD course time, such as is used in Time2Beat NO FEO

TnT (Twist N Turn) class can only be entered by a paper entry – online entries are not possible

INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners** program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
